

About Token Swaps




Instantly swap crypto tokens: no registration or account needed. For now the swap feature uses liquidation PancakeSwap which is the leading decentralized exchange on the Binance Smart Chain, with the highest trading volume on the market. We do not take any fees, the known fees come from pancakeswap. Similar with pancake swaps, we are not hold your funds when you trade: you have 100% ownership.

In the future, we will complement swaps with the OTC (OVER THE COUNTER) feature which is different with swap. OTC does not apply a price impact while exchanging. So it is more profitable.

About Sakura Farms




Sakura Farms is a decentralized financial protocol that provides profit sharing from transaction fees earned in the form of WEBOO tokens. The entire process is run by smart contracts. It is automated, transparent and secure. It allows users to increase their wealth in a safe and decentralized manner.

The distributed WEBOO comes from a tokenomic fee which is 10%. With this method it is possible to provide a high APR, and maintain the token price in the market.

Matcha pools is a process that involves committing your crypto assets to support the liquidation of WEBOO. Participants pledge their coins to the cryptocurrency protocol. From these participants, they will get a reward in the form of WEBOO. Rewards can be claimed at any time.



OTC (Over The Counter)

About OTC




An over-the-counter (OTC) trade is participants trade tokens following the market price without incurring a price impact. Thus, enabling more profitable trades.

In an OTC market, "webooswap.com" acts as a market maker by quoting prices from "pancakeswap.finance". Just like the swap market, anyone can add liquidation. The OTC market makes it possible to add liquidation with just one asset contract.

Weboo Wallet

About Weboo Wallet



We create a weboo wallet to make it easier for holders and farmers to use the weboo ecosystem. Our dApps are specially designed for shortcuts to popular dApps but on weboo pages, attracting partnerships, and integrating all weboo ecosystems. In addition, the prices that appear on the Weboo wallet platform are directly taken from the coin exchange, so that all coins that already have liquidity on the exchange can be displayed.

Weboo wallet is perfect for those who buy tokens during presale. It can calculate and manage their portfolio. We also provide trade shortcuts for all listed coins. Weboo wallet also supports multiple RPC, so if there is an RPC that is blocked in a country, it will automatically switch to an open RPC.

NFT Game



Mechaverse is an NFT game that allows anyone to sell and buy characters, weapons and gear to other players. In addition, there is a minting feature where players will get dividends according to the items they have.

Characters and items owned will be managed in a decentralized manner, so players will feel safe.
